- 1. We offer a 12 hour notice period on padel court bookings for cancellations. If the cancellation falls inside the 12-hour notice period, then the full cost of the booking will be applied by Playtomic, the 3rd party application used for padel bookings.
- 2. If you have booked an open match then the cancellation policy is 24 hours. If the cancellation falls inside the 24-hour period then the full cost of the booking will be applied.

2. Padel Court Bookings and Fees: Court Bookings & Fees
